AN ACT

Amending the act of December 29, 1972 (P.L.1713, No.367), 1 entitled "An act concerning motor vehicle physical damage 2 appraisers; providing for the licensing of persons engaged in appraising physical damages to motor vehicles; fixing fees and prescribing unlawful acts and penalties," further 5 providing for compliance with act. 6 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 9 Section 1. Section 11(c) of the act of December 29, 1972 10 (P.L.1713, No.367), known as the Motor Vehicle Physical Damage 11 Appraiser Act, is amended to read: 12 SECTION 1. SECTION 11(B) AND (C) OF THE ACT OF DECEMBER 29, <--1972 (P.L.1713, NO.367), KNOWN AS THE MOTOR VEHICLE PHYSICAL 13 DAMAGE APPRAISER ACT, ARE AMENDED TO READ: 14 15 Section 11. Compliance with Act. -- * * * 16 THE APPRAISER SHALL [LEAVE] FURNISH A LEGIBLE COPY OF 17 HIS APPRAISAL WITH [THAT OF] THE REPAIR SHOP SELECTED BY THE 18 CONSUMER TO MAKE THE REPAIRS AND ALSO FURNISH A COPY TO THE

OWNER OF THE VEHICLE. THIS APPRAISAL SHALL CONTAIN THE NAME OF

- 1 THE INSURANCE COMPANY ORDERING IT, IF ANY, THE INSURANCE FILE
- 2 NUMBER, THE NUMBER OF THE APPRAISER'S LICENSE AND THE PROPER
- 3 IDENTIFICATION NUMBER OF THE VEHICLE BEING INSPECTED. ALL
- 4 UNRELATED OR OLD DAMAGE SHOULD BE CLEARLY INDICATED ON THE
- 5 APPRAISAL WHICH SHALL INCLUDE AN ITEMIZED LISTING OF ALL
- 6 DAMAGES, SPECIFYING THOSE PARTS TO BE REPLACED OR REPAIRED.
- 7 BECAUSE AN APPRAISER IS CHARGED WITH A HIGH DEGREE OF REGARD FOR
- 8 THE PUBLIC SAFETY, THE OPERATIONAL SAFETY OF THE VEHICLE SHALL
- 9 BE PARAMOUNT IN CONSIDERING THE SPECIFICATION OF NEW PARTS. THIS
- 10 CONSIDERATION IS VITALLY IMPORTANT WHERE THE PARTS INVOLVED
- 11 PERTAIN TO THE DRIVE TRAIN, STEERING GEAR, SUSPENSION UNITS,
- 12 BRAKE SYSTEM OR TIRES.
- 13 (c) [No appraiser shall secure or use repair estimates that
- 14 have been obtained by the use of photographs, telephone calls or
- 15 in any manner other than a personal inspection.] An appraiser
- 16 may prepare a repair estimate obtained by personal inspection or
- 17 by photographs, videos or telephonic means. An appraiser may not
- 18 require the owner of a vehicle to submit SUBMISSION OF
- 19 photographs or videos in order to obtain an appraisal. AN <--

- 20 APPRAISER, OR AN INSURER AS PART OF THE APPRAISAL PROCESS, SHALL
- 21 DISCLOSE TO THE OWNER OF THE VEHICLE THAT THERE IS NO
- 22 REQUIREMENT TO SUBMIT PHOTOGRAPHS OR VIDEOS IN ORDER TO OBTAIN
- 23 AN APPRAISAL.

- 25 Section 2. This act shall take effect in 60 days.
