AN ACT

- Amending the act of July 6, 1989 (P.L.169, No.32), entitled, as amended, "An act providing for the regulation of storage 2 tanks and tank facilities; imposing additional powers and 3 duties on the Department of Environmental Protection and the Environmental Quality Board; and making an appropriation," in 5 financial provisions, further providing for Underground 6 Storage Tank Indemnification Board. 7 8 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- 10 Section 1. Section 703(a) of the act of July 6, 1989
- 11 (P.L.169, No.32), known as the Storage Tank and Spill Prevention
- Act, is amended to read: 12
- 13 Section 703. Underground Storage Tank Indemnification Board.
- 14 Establishment of board, appointment and terms. -- There is
- hereby created the Underground Storage Tank Indemnification 15
- Board which shall consist of ten members. The Insurance 16
- 17 Commissioner and the Secretary of the Department of
- 18 Environmental Protection shall be ex officio members. Eight
- 19 members shall be appointed [by the Governor,] as follows:
- 20 Six members who shall be persons with particular (1)

- 1 expertise in the management of underground storage tanks.
- 2 Three of these members shall be appointed for terms of four
- 3 years and three shall be appointed for a term of three years.
- 4 The Governor shall appoint [the members,] two members, the
- 5 President pro tempore of the Senate shall appoint one member,
- 6 the Speaker of the House of Representatives shall appoint one
- 7 <u>member, the Minority Leader of the Senate shall appoint one</u>
- 8 <u>member and the Minority Leader of the House of</u>
- 9 Representatives shall appoint one member. The appointments
- 10 <u>shall include</u> one each from a list of nominees provided by
- 11 each of the following:
- 12 (i) The Associated Petroleum Industries of Pennsylvania.
- 14 (ii) The Pennsylvania Petroleum Association.
- 15 (iii) The Service Station Dealers and Automotive
 16 Repair Association of Pennsylvania and Delaware and the
 17 Petroleum Retailers and Auto Repair Association, Inc.
- 18 (iv) [The Middle Atlantic Truck Stop Operators] <u>The</u>
 19 Pennsylvania Food Merchants Association.
 - (v) The Pennsylvania Farm Bureau, Pennsylvania State
 Grange and Pennsylvania Farmers Union.
- 22 (vi) The Tank Installers of Pennsylvania.
 - (2) [One] The Governor shall appoint one local government member who shall have knowledge and expertise in underground storage tanks. The local government member shall be appointed for a term of two years.
- 27 (3) [One] <u>The Governor shall appoint one</u> public member 28 who shall not be an owner or operator of storage tanks nor 29 affiliated in any way with any person regulated under this 30 act. The public member shall be appointed for a term of three
